**Smart Buy Auto Loans are not eligible for a skip payment.** Skipped payments on auto loans are not covered by GAP. All transactions are governed by California State Law. If loan is protected by Member's Choice™ borrower security debt cancellation protection, these charges will continue to accrue. An approved Skip-A-Payment request will extend the term of the loan. Interest will continue to accrue during the month skipped. Loan not to exceed two skips per year or five per lifetime of the loan. Not all loans are eligible for a skip.

I (we) hereby authorize America's Christian Credit Union (ACCU) to initiate debit entries to my (our) account indicated above at the depository financial institution named above, hereafter called DEPOSITORY, and to debit the same to such account. I (we) acknowledge that the origination of ACH transactions to my (our) account must comply with the provision of U.S. law. This authorization is to remain in full force and effect until ACCU receives written notification from me (or either of us) of its termination in such time and in such manner as to afford ACCU a reasonable opportunity to act on it. I agree to the terms and conditions set forth for my account as contained in ACCU's Terms and Conditions, Electronic Transfers, Funds Availability and Truth-in-savings Disclosure. For a Pay-off of a secured loan, any liens associated will be released within the mandated time frame. Any ACH payments that are returned, may result in a fee.
